Saurya Urja Company of Rajasthan Limited ("Saurya Urja") is a 50:50 Joint Venture Company of Government of Rajasthan (GoR) and IL&FS Energy Development Company Limited (IEDCL). The Company was started in the year 2015 with a mandate to develop 5000 MW of Solar Power Parks in the state of Rajasthan and is specialized in infrastructure development for renewable energy projects.

Saurya Urja has developed a 1000 MW Solar Park in Village-Bhadla, District-Jodhpur over 5500 acres of land as its first project. While developing this solar park, it has improved the lives of over 25000 local habitants through its social initiatives.

Concept and Philosophy for social initiatives

Social welfare and contribution towards society has been an integral part of Saurya Urja. For more than 4 years, Company's CSR and Local Area Development initiatives have played a vital role in improving the lives of the communities. Saurya Urja's philosophy is that **'Business & Social welfare are the two legs of a person called "Corporate", both have to move together for its growth.'**

Saurya Urja has been contributing towards upliftment of lives of local people who resides around the Solar Park since FY 2016-17. To analyze the gaps and need of local community, detailed surveys and studies were being conducted by the Company and based on the assessment study and mapping of the people living in the area in terms of occupation, education etc., Saurya Urja had identified specific projects for implementation in sectors of:

- Health (including Health Infrastructure)
- Education + Development of Sports (including School Infrastructure & Transportation)
- Water (including Infrastructure, Availability & Access)

- Placement linked Skills Program for local population
- Village Infrastructure Development

The interventions included renovation of public-school infrastructure including drinking water, toilets, bus stands, construction of public roads, water harvesting systems, water tanks, tube wells, organizing routine health camps as well as veterinary camps, running of learning centers for school dropouts, establishment of computer lab, mobile science labs, sports training, Skill Development Institute etc. The Company is working at studying a larger area for taking up large scale social inclusion programs.

Saurya Urja does social welfare in the following ways:



Till date, Saurya Urja has influenced the lives of more than 25000 people through its social welfare activities. Total incurred amount towards these activities is more than Rs. 15 Crores and Saurya Urja is committed to spend much more towards the social welfare.

DETAILS OF ACTIVITIES

Following are the glimpse of activities done by Saurya Urja under CSR and Local Area Development during the FY 2019-20:

Corporate Social Responsibility (CSR):

At Saurya Urja, CSR has been an integral part of the way we have been doing our business since incorporation. For more than 4 years, the Company's Local Area Development initiatives has played pivotal role in improving the lives of the communities and society at large and in & around our project area with an objective to ensure inclusive socio-economic development of the region. This has also enabled us to fulfil our commitment to be a socially responsible corporate citizen.

Saurya Urja will endeavour to continually strengthen development multipliers of our projects through supporting interventions which lead to a sustainable and inclusive growth. This will primarily entail undertaking a variety of programs for enhancing economic activity and skill, which

will be supplemented with interventions to improve the quality of life of stakeholders in the project catchment areas.

CSR became applicable on Saurya Urja in the FY 2018-19. Accordingly, the Board of Directors had approved a budget of Rs. 67 Lakhs to be spent under CSR activities for the year. Out of this budget, Company has spent Rs. 39 Lakhs during the FY 2019-20. The projects undertaken are within the broad framework of Schedule VII of the Companies Act, 2013. Details of the projects undertaken during the FY 2019-20 is as under:

1. Education:

In the fields of education, Saurya Urja is doing a remarkable work. The focus area of Saurya Urja is to provide basic education to everyone and improve infrastructure of the local schools.

Following activities to promote education are being carried out by Saurya Urja in the local area under its CSR mandate for the FY 2018-19

Learning Centres and other activities:

During the survey, it was observed by the Company that local community is not interested in sending their kids to the schools. Therefore, the government schools got closed due to less enrolment at various places. To address this concern, we initiated massive efforts with the help of local NGO and started meeting with the local community. We made them realize that education is a must. After taking them in confidence, we started learning centres i.e. private schools in those areas where government schools were closed. Apart from the learning centres, we also had massive campaign to increase enrolments in the government schools and to encourage parents to send their children to the schools. Saurya Urja is presently running 3 such learning centres. As an achievement, one boy and three girls got success in class 10th examination though open school. These children have never seen the door of any school and got passed class 10th through these learning centres. Media has also given coverage to these achievements. Some glimpse are as follows:



Learning Centres where schools are not functioning, life skill training, science fairs, workshops, etc.

Distribution of 1000 school bags (Yelo Bags)

School infrastructure like class rooms, toilets, boundary at Government Primary - Kunjal School, Village-Bhadla (to be completed in FY 2020-21)

Renovation of toilets at 6 local schools (to be completed in FY 2020-21)

Education



The focus is to **provide basic education** & improve the infrastructure of the local schools



Distribution of 1000 specialized school bags:

During our survey, we found that, without a school bag and writing desk, following problems were being faced by students:

- i. Books getting lost or torn or wet, by midsession mostly the books are in such bad shape that kids cannot even read from them.
- ii. Kids losing their stationary like pen, pencil, eraser etc.
- iii. Extremely uncomfortable posture to sit and study for long hours; back and neck ache at very early age

We had identified these gaps in the region and found that a good quality school bag and sitting chair/reading desk is a basic need of school going children. To cater this bottleneck, we had procured 1000 specialized school bags which has sitting stool/writing desk. This specialized school bag was appreciated by each and every person including the government officials. The Bags were distributed by Surya Urja to students in 11 Nos. Schools and 2 Nos. Learning Centers in Bhadla & its nearby villages.



Development of Computer Lab at Government School:

Saurya Urja has developed a computer lab at a local Government School.

To develop this computer lab, we had collaborated with the concerned school, took their written request and ensured that they have the sufficient staff to operate and maintain the lab and to teach computer to the children.

The Computer lab has following items:

- i. 4 nos. of desktop computers
- ii. 1 no. of projector
- iii. 1 no. of printer
- iv. UPS
- v. Speakers

School infrastructure at Government Primary School, Village-Bhadla:

Saurya Urja has adopted a government school at Bhadla village and is doing the following activities in the schools:

- i. Complete repairing & painting of 3 halls
- ii. Construction of toilet
- iii. Construction of main gate
- iv. Construction of boundary in 5 Bigha area
- v. Complete repairing of kitchen
- vi. Grading & levelling works in school area
- vii. Provide items viz. children sitting mats, table stool for children, educational painting in three class rooms, library, water camper, sports equipment, teacher tables, teaching aid material etc



Renovation of toilets at 6 local schools:

Proper sanitation is the basic need of a human being and these good habits should be introduced in the school life of a child. It was observed by Saurya Urja that at the local schools, there is no

facility for proper sanitation and also separate toilets for girls and boys

Therefore, Saurya Urja is also repairing and renovating toilets at 6 local schools in first phase.



2. Health:

In the fields of preventive healthcare, Saurya Urja has done a great work. The focus area of Saurya Urja is to educate local people about basic health issues and treat them at their doorstep.

To achieve these objectives, we had collaborated with local NGO and started various activities. During FY 2019-20 we have done following activities related to healthcare under CSR:

Health Camps and other activities:

During the survey, it was observed by Saurya Urja that the local population in the area is very scattered and basic healthcare is out of the reach of most of them. To provide doorstep healthcare, we started organizing health camps in the dhanis and villages from regular intervals. It was also observed that the primary assets and source of earning of the locals are their livestock. There was no veterinary healthcare facility.

To address these issues, we started organizing veterinary health camps where vaccination and treatment of livestock of local people are being taken care. Company has been organizing these health camps since 2018. During the FY 2019-20, total 36 Health Camps and 12 Veterinary Health Camps have been organized where around 4077 patients and 14888 livestock got benefitted. Also, special camps and drives were organized for maternal and child health & nutrition care at Anganwadi Centres.

Anganwadi development



Anganvadi Development:

Company has been very active in development of base level infrastructure in the local area of its Solar Park. While, the Company has developed one

Anganvadi kendra at Kalu Khan ki Dhani during FY 2019-20, it has also developed quite few in the past.



The focus is to educate locals about **basic health issues** & treat them at their doorstep.

To improve the infrastructure, the Company has **constructed school buildings, water tanks, roads, etc.**



3. Village Infrastructure:

To improve basic infrastructure of the village, Company has been doing activities such as construction of school buildings, water tanks, water harvesting systems, public roads, etc. During the FY 2019-20 Company has undertaken following activities:

Village Infrastructure

Construction of Bus Stands at Noore ki Bhurj and near Solar Park gate

During the FY 2019-20, Company has developed 2 nos. of Bus Stands at prominent places of the Bhadla area. During the summers, it is very difficult to stand under direct sunlight in this area. To cater this need, Company had developed these bus stands and intends to continue building such infrastructure.



Local Area Development (LAD):

Pursuant to the Implementation and Support Agreement (ISA) executed by the Company with Solar Power Developers (SPDs), Company has to develop the local area of the Solar Park by managing the Local Area Funds provided by the SPDs. In compliance of the above, Company has undertaken various activities during the FY 2019-20. Company has spent around Rs. 92 Lakhs for the following activities during the FY 2019-20:

1. Skill Development & Solar Training Institute at Phalodi and Bhadla

Company has developed "Skill Development & Solar Training Institute" at Bhadla along with its branch in Phalodi to provide employment-based skill training to the local youth.

Skill Development Center at Bhadla:

- This center was started by the Company in February 2020 as pilot project.
- First batches of both the courses have been completed and practical training and assessment is pending due to Covid-19. Following courses are being offered at this center:
 1. Solar PV Installer (Minimum Qualification is 10th Class) (400 Hrs. training)
 2. Plumber General (Minimum Qualification is 5th Class) (420 Hrs. training)

Skill Development Center at Phalodi:

This center is ready with all Infrastructure. A building has been taken on lease at prominent places of Phalodi. Following courses are being offered at this center:

1. Mason General (Minimum Qualification is 5th Class) (500 Hrs. training)
2. Self Employed Tailor (Minimum Qualification is 8th Class) (440 Hrs. training)
3. Sales Associate (Minimum Qualification is 10th Class) (500 Hrs. training)
4. Domestic Data Entry Operator (Minimum Qualification is 10th Class) (500 Hrs. training)

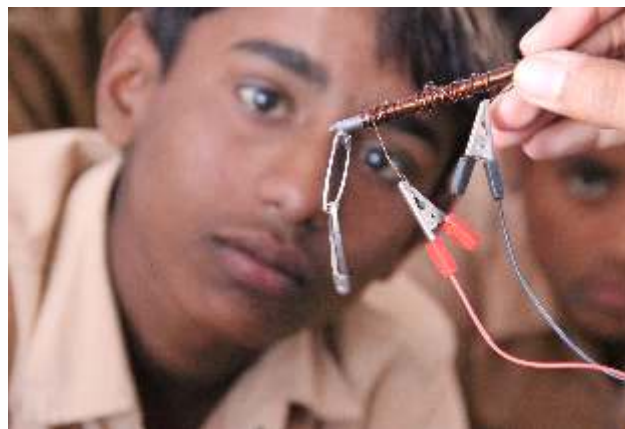
2. Fire Service Station:

Considering critical need of local people and all the solar parks in the region, a Fire Station has been developed by the Company. The station is fully equipped with a Fire Tender vehicle and a dedicated station built in 1750 Sq Ft. with 2 rooms and parking shed. This fire tender has been used during fire incident in Solar Plant and during fire accidents in Bhadla area.



3. Mobile Science Labs "Science on Wheels" project in 22 Government Schools:

- In most government schools specially in the Bhadla Solar Park area there is a need to develop the infrastructure, tools or resources to create an interactive and sustainable approach to learning
- Therefore, the Company has introduced a system of providing innovative experiment-based



learning experience to the children of 22 Government schools through movable Science Labs

- The program will encourage scientific temperament and an inquiry-based approach to learning of science. The target population is 2000 students approximately in the age group of 11 to 13 years
- Through this program, Company is expecting that school enrollment and attendance of the students will be increased in the current year

4. "Sports Training" project in 34 Government Schools

- Sports education is a curricular model in physical education that aims to help students "develop as competent, literate, and enthusiastic sportspersons".
- During initial assessment in Bhadla area, it was observed that students were not used to play even the traditional sports such as kabaddi and volleyball.
- Company is developing infrastructure within the 34 government schools, providing sports training and equipment.
- Through this program Company expects encouragement of Sports Education and holistic (physical, social and cognitive) development of the students in 34 government schools and 2 learning centers, targeting more than 3000 students of schools in 3 panchayats of bap block in Rajasthan.



Implementation of the above projects:

Saurya Urja has implemented the above projects in collaboration either with the implementing agency or the beneficiary itself. This methodology makes the implementation effective and help the facility to affect the needy person directly. Before implementing each intervention, Saurya Urja had taken concurrence with the people who have benefitted with the intervention.

Monitoring and Governance:

For the monitoring and governance of the above projects, Saurya Urja has a special procedure. Saurya Urja has a dedicated team for its CSR activities. After implementing of each project, timely review happens and a report goes to the CSR Committee and Board.

Feedback of eminent personalities:

1. **Mr. Govind Singh Dotasara (Honourable Education Minister of Rajasthan):**
It is very pleasant to see such news. Girls have passed class 10th examination from open school because government school was closed due to lack of enrolment.
2. **Mr. Hakam Khan (Additional District Collector, Phalodi):**
The Skill Development and Solar Training Institute being run by Saurya Urja will make the youth self-independent and employable.

Impact:

In Summary efforts of Saurya Urja over last 3 years has resulted in

- Improved quality of lives of over 25,000 people.
- Increased enrollments in the Government Schools
- Improvement in vaccination and preventive healthcare.
- Improved quality and storage facility of water to awareness in basic health and sanitation.

Saurya Urja has demonstrated its commitment in supporting the local community and will continue its efforts in future as well

Future Plans:

Further, Saurya Urja has developed the following plan for the development of remote areas of Rajasthan region:
